	I have to continue the work that live dains. The Fact Cide of Austin and Travia County
Ron Davis	I hope to continue the work that I'm doing. The East Side of Austin and Travis County was once neglected and put-upon. I strive to make the East Side as good or better as any other part of our community. I started out by fighting what was bad—garbage dumps, sludge farms, gravel mines—and have made strides in bringing in what's good—a solar farm near Pflugerville, a new civil aviation airport, parks and conservation land, and east-west thoroughfares connecting State Highway 130 to the core city. Over 40% of the last Travis County bond package went to Precinct One, and I'll take that as my report card on how doggedly I look for opportunities to improve Precinct One. In 2003, I was the first to advocate Travis County intervening in the federal courts on the matter of Congressional redistricting. Travis County's standing as a plaintiff allowed us to propose a remedy resulting in the 2006 boundaries that brought Lloyd Doggett back into Central Texas and more into Travis County. Through our current involvement with Congressional and legislative redistricting, we are tenaciously arguing that Lloyd Doggett's Congressional District 25 deserves protection as a coalition district. Since I am a beneficiary of the coalition building that is the very fabric of Travis County politics, I firmly believe in this cause and wish to see it through.

	I am very interested in three main issues, and I desire to continue working on them as your Travis County Commissioner, Precinct 3. 1. Water is a huge on-going problem in our region and I have worked diligently to assure that we have a reliable and safe supply for the future. I took the lead in organizing, funding and producing the first-ever economic impact study of Lake Travis – a critical tool needed by policymakers for determining minimum lake levels for our water supply needs in Travis County. I have represented Travis County interests at LCRA and at Legislative hearings. I also led the County in contributing to and supporting the local acquisition of water and wastewater utilities targeted for divestiture by LCRA. At my request, the County developed a stakeholder process to review the groundwater issues in the county and make new rules to protect existing and future residents' groundwater resources. 2. Transportation Issues. (1) Led Travis County in partnering with the City of Austin and TXDOT to create an interim fix to the Y in Oak Hill. (2) Better transportation planning – I identified and led the effort at CAMPO to increase and diversify the membership of CAMPO's Technical Advisory Committee which allows for more consideration of other infrastructure components for transportation planning. e.g. housing that is affordable should not burdened with a new toll road that is unaffordable to those residents; roads should be built where there is water available to support growth, etc. 3. Wildfire Response – I organized a County Task Force to meet with new challenges in wildfire response created by the devastating wildfires experienced in Travis County last year. (The Pinnacle fire and the Steiner Ranch and Spicewood fires were in Precinct 3.) The effort is on-going and includes community preparedness (Ready, Set, Go! brochure), improved public information during a crises, and increased coordination between agencies involved in emergency response. Have initiated a rule review to require appropriate emergency e

County Attorney David Escamilla	I have not conducted sufficient research upon this legal question and, as a lawyer, am therefore hesitant to provide actual legal advice on this question. But I would support passage of such a law so that we could at least get the opportunity for a favorable ruling in the courts.
Sheriff John Sisson	LGBT couples should be afforded the same opportunity as any other couple to adopt children and to be parents.
Tax Assessor- Collector Bruce Elfant	I don't know whether such legislation would be compatible with the Texas Constitution but I absolutely support adoptive rights for gay, lesbian, bi-sexual or transgendered foster parents.
Commissioner Pct 1 Ron Davis	Yes and yes.
