Question 8 Given the outcome of Prop. 2 in 2006, do you believe the Texas Constitution would allow a State law that would quarantee to gay, lesbian, bi-sexual or transgendered foster or adoptive parents (prospective or current) the same rights and protections afforded under current law to heterosexual foster or adoptive parents (prospective or current)? Would you advocate for and support

such a state law?

District Attorney

Rosemary Lehmberg I think overturning this proposition will be difficult given the current legislature, but I believe it should be. The law is discriminatory and unconstitutional. Clearly, we need to continue to take this issue to the courts, as the courts are the most informed and have a history of enforcing civil rights.

Donna Howard I am not a lawyer, but I do believe the Texas Constitution already affords lesbian, bisexual or transgendered foster or adoptive parents the same rights and protections as heterosexual foster/adoptive parents. Prop. 2 specifically dealt with marriage and civil unions and there is no requirement that a prospective or current adoptive/foster parent be married. If deemed necessary, I would support a state law affording all adoptive parents the same set of rights.

Chris Frandsen I personally believe that "marriage" is a religious institution and the state has no standing in who should or should not marry. I believe that the "marriage license" is a document which the state uses to creating a legal relationship between two consenting partners and that gender, race or religion should play no part in determining who may be consenting partners. I would hope that the courts would find that way as well. If not I would support and advocate a law that removes consideration of gender, race and religion in determining who does or does not have parental rights.

Rebecca Bell-I would advocate a state law guaranteeing gay, lesbian, bi-sexual or transgendered Metereau foster or adoptive parents the same rights and protections afforded under the law to heterosexual foster or adoptive parents.

Question 9	Should the State of Texas provide the same benefits to the domestic partners of gay and lesbian State employees that it does to its married, employees? Does Prop. 2 constitutionally prevent domestic partnership benefits for public employees?
District Attorney Rosemary Lehmberg	The State should do so, as the City and County have done. I don't believe Proposition 2 prohibits domestic partnership rights.
State Representative Donna Howard	Yes, the domestic partners of gay and lesbian state employees should get the same benefits. Again, I am not a lawyer, but I think the proponents of Prop. 2 intended it to prevent domestic partnership benefits.
Chris Frandsen	Yes. No.
	The State of Texas should provide the same benefits to domestic partners of gay and lesbian State employees, and Proposition 2 is unconstitutional, in my view.

I think private employers are often much more open minded and practical about these issues. Private employers should be able to provide these benefits if they believe it is the right thing to do.
