

Wesley Faulkner	APD should make improvements in their sensitivity towards all groups including LGBTQ citizens.
Delia Garza	I'm proud that our City has an LGBTQ Liaison that serves as part of our Police force, and that we had a rainbow police car in the recent PRIDE Parade to show that protecting and honoring the LGBTQ community is part of our public safety culture. We've come a long way, but there is always room for improvement. I am committed to supporting efforts to increase sensitivity training for all of our public safety agencies and City departments, and improve resources and protections for our LGBTQ community. We must foster ongoing conversations to hear directly from our LGBTQ residents about what's working well and how we can continue to make strides forward together.

Question 6	If elected, would you act to increase recruitment of LGBTQ employees for the police, fire, and emergency medical services? What proposals would you suggest to make coming out on the job safer for LGBTQ employees?
Wesley Faulkner	As one of the largest employers in Austin, the city should make it a safe place to work for everyone. One of the mandates of the Chief Equity Officer should be to ensure that the LGBTQ community is welcomed.
Delia Garza	We have one of the best public safety teams in the country, largely because we work toward fostering diversity in our workforce. I believe we should work harder to recruit LGBTQ employees for both public safety and nonsworn positions, but also protect the right to privacy. Applicants should not be required to disclose their sexual orientation, but we should work closely with LGBTQ partner organizations during our recruitment processes, and continue to make it clear that all are welcome and considered assets as part of our City of Austin family in an effort to attract more LGBTQ candidates during our hiring processes.



Delia Garza	I'm proud that the City covers transgender transition procedures through our benefits package for City employees and fosters a culture of inclusion. We must remain diligent to ensure that we're leading nationally as welcoming and inclusive by providing meaningful benefits and opportunities for members of the LGBTQ community.
Question 8	If elected, would you continue to uphold the current requirement that a company that receives economic incentives from the City not discriminate against its LBGTQ employees?
Wesley Faulkner	Yes.

Any company seeking incentives should be held to the same high standards that we require of ourselves, including maintaining antidiscrimination policies and providing domestic partner benefits. If Council approves incentives, it should only be in the case where we're creating good jobs that provide opportunities that also align with our community values.
Question 9	How familiar are you with organizations, such as Out Youth, the Austin Gay & Lesbian Chamber of Commerce, and AIDS Services of Austin that serve the LGBTQ community? If elected, would you support increased funding for the services organizations like these provide? What services do you think are crucial for LGBTQ residents?
Wesley Faulkner	Yes I am familiar and would support increased funding to help more people. AIDS Services are still very important and needs more attention.
Delia Garza	I'm familiar with all of the organizations listed, and respect the work they do for our community. We should continue our strong partnership with the Austin Gay & Lesbian Chamber of Commerce to help ensure that our small businesses reflect the makeup of our diverse community, and support efforts of critical services providers such as AIDS Services of Austin and Out Youth. I would welcome a meeting with SDA to discuss how we can strengthen existing relationships and build new relationships with organizations that serve our LGBTQ community.

	I will be transparent about my beliefs and won't shy away from the important decisions and choices that support equality.







I was proud to lead on the creation of a new health equity program through our Health and Human Services Department, which aimed to expand the populations we serve and the types of services we provide. These services were grouped in five categories based on expertise from community advocates and our HHS Staff, which included funding to provide services for LGBTQ People of Color Sexual Health and Wellness. I also led on a historic expansion for health and human services and social services funding to provide services for our most vulnerable, including the LGBTQ community. I'll gladly continue these efforts to ensure everyone in our community has access to the critical services they need.

Question 11	Do you support the requirement that all single-occupancy public restrooms are made available to all people, (for example families and transgender people)?
Wesley Faulkner	Yes, there is no reason not to.
Delia Garza	Absolutely. I'm supportive of the ordinance passed by the previous Council, and proud of our City for standing firm in support of this policy. It's been disheartening to see the struggles other communities have gone through trying to implement this practice, and Austin's embracing of this policy is one of the many things that makes me proud to call this City home.

	This is something the city could do directly for all of its facilities. The city can also do more in their vocalization of those polices we support.

While Council doesn't have direct jurisdiction over policies at our public schools, I would gladly advocate on behalf of these policies whenever necessary.

Question 15	Have you attended functions in Austin's LGBTQ community and, if so, which?
Wesley Faulkner	Yes. I attended the Pride Parade just the other week.
Delia Garza	I was honored to have the opportunity to attend the National Democratic Convention this year. Given our current political climate and the recent tragedy in Orlando, I was incredibly thankful to see so many Democrats speak to the importance of supporting and standing with our LGBTQ community. I'm proud to be part of a community of allies that choose to rise above the demeaning political rhetoric and violence that we have seen recently to show that the larger part of our community stands beside our LGBTQ friends and family. I am also always moved by the AIDS Memorial Quilt Project that comes to City Hall annually. It serves to remind us not only of those who we have lost, but the importance of continuing and expanding HIV and AIDS services to prevent future losses to our community. One of the most meaningful events that recently occurred happened when the Supreme Court decision was reached that made it legal for our LBGTQ community to legally marry. I was on maternity leave, but took my newborn daughter, Lourdes down to City Hall to take a picture with the rainbow flag hanging from the building to memorialize the historic day. My hope is that this is one more step that will allow her to grow up in a new generation that will only know a culture that is accepting of everyone in our community regardless of race, gender, sexual orientation, or gender identity.
